Section 4: UNOPS Technical specifications, LOT 3 is hereby amended as follows:

LOT 3 – Deltamethrin or equivalent-based biocide to combat adult mosquitoes

The biocide (insecticide) with deltamethrine or equivalent as active matter (2%) is a liquid concentrated water emulsion, useful for ULV application.

The recommended dosage of active ingredient based on 2% of deltamethrin or equivalent for the purposes of combating adult mosquitoes using ULV devices is 50ml/ha of the treated surface, i.e. 1 g of active ingredient deltamethrin or equivalent per hectare.

Areas where adult mosquitoes shall be treated with deltamethrine-based substance are territories of cities and municipalities affected by floods. Treatment shall be performed on green areas, in parks, forest parks, river bank areas, aits, threatened residential zones in urban parts of the city, in green areas of all pre-school institutions and schools, suburban and rural areas, where the presence of adult forms of mosquitoes is detected.


Dosage of the substance shall be defined on the basis of monitoring results regarding the species, number of adult mosquitoes and depending on the characteristics and level of infestation for particular areas where it will be applied.

The type of treatment mosquitoes, scope and the dosage of said biocide will be defined on the basis of the monitoring results on the species, the number of adult forms of mosquitoes, as well as depending on the characteristics of the area in which the treatments are applied.

The deltamethrine-based biocide shall be delivered in original packaging.

When delivering the deltamethrine-based biocide in the quantity according to the client's requirements, samples of the delivered substance will be sampled at random and shall be provided to authorized professional laboratory to control the content of active substances and biological efficacy testing in laboratory conditions.
